7 **A Resolution authorizing the County Executive to execute a one-year policing contract with**
8 **the County of Summit Developmental Disabilities Board, to provide three Sheriff's**
9 **Deputies and three one-third shifts of a vehicle, for the period 6/1/14 through 5/31/15, for**
10 **the amount of \$297,643.52, for the Sheriff, and declaring an emergency.**

12 WHEREAS, the County of Summit Developmental Disabilities Board ("DD Board") and
13 the DD Board wishes to enter into a one-year policing contract with the County of Summit to
14 provide three County Sheriff's Deputies and three one-third shifts of a vehicle, for the period
15 6/1/14 through 5/31/15; and

17 WHEREAS, the DD Board has agreed to pay the County the amount of \$24,803.63 per
18 month, for total of \$297,643.52, for the period 6/1/14 through 5/31/15, and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned policing contract is necessary and in the best interest of the County of
22 Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that;

27 SECTION 1

29 The County Executive is hereby authorized to execute a one-year policing contract with
30 the County of Summit Developmental Disabilities Board ("DD Board"), to provide three
31 Sheriff's Deputies and three one-third shifts of a vehicle, for the period 6/1/14 through 5/31/15,
32 for the amount of \$297,643.52. The DD Board has agreed to pay the County the amount of
33 \$24,803.63 per month, for a total amount of \$297,643.52 for the one-year term of the policing
34 contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety, and
39 welfare of the citizens of the County of Summit and for the further purpose of immediately
40 providing necessary policing to County of Summit Developmental Disabilities Board effective
41 6/1/14.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
