7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract renewal (second of two) with Courtview Justice Solutions, Inc., for case**  
9 **management system maintenance and support, for the period 1/1/15 through 12/31/15,**  
10 **approved by the IT Board 9/16/14, as Best Practical Source, in an amount not to exceed**  
11 **\$59,498.00, for the Court of Common Pleas Probate Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held September 17, 2014, awarded a  
14 professional service contract renewal (second of two) with Courtview Justice Solutions, Inc., for  
15 case management system maintenance and support, for the period 1/1/15 through 12/31/15,  
16 approved by the IT Board 9/16/14, as Best Practical Source, subject to confirmation by County  
17 Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that the contract renewal is necessary and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

27 The award by the Board of Control of a professional service contract renewal (second of  
28 two) with Courtview Justice Solutions, Inc., for case management system maintenance and  
29 support, for the period 1/1/15 through 12/31/15, approved by the IT Board 9/16/14, as Best  
30 Practical Source, in an amount not to exceed \$59,498.00, is hereby confirmed and the County  
31 Executive is hereby authorized to execute such contract renewal.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and  
36 welfare of the citizens of the County of Summit, and for the further reason to immediately  
37 provide for case management system maintenance and support effective 1/1/15.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.

48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
49 deliberations of this Council and of any of its committees that resulted in such formal action,
