7 **A Resolution authorizing the County Executive to execute a three-year policing contract**
8 **with Northfield Center Township, in Council District 1, for the period 1/1/15 through**
9 **12/31/17, in exchange for payment by Northfield Center Township of a total amount of**
10 **\$2,361,266.14, for the Sheriff, and declaring an emergency.**

12 WHEREAS, County Council previously adopted Resolution No. 2011-362, which
13 authorized the County Executive to execute a three-year policing contract with Northfield Center
14 Township in Council District 1, which expired on 12/31/14; and

15
16 WHEREAS, Northfield Center Township has requested that the County of Summit enter
17 into a new contract pursuant to which the County Sheriff will provide 11,746.87 deputy/sergeant
18 hours, for the period 1/1/15 through 12/31/17, and

19
20 WHEREAS, Northfield Center Township has agreed to pay the County \$769,287.09 for
21 the first year, \$787,258.53 for the second year and \$804,720.52 for the third year, for a total
22 amount of \$2,361,266.14 during the three-year term of the contract; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the County
26 Executive to execute the aforementioned policing contract with Northfield Center Township;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that;

31 SECTION 1

33 The County Executive is hereby authorized to execute a three-year policing contract with
34 Northfield Center Township, in Council District 1, pursuant to which the County Sheriff will
35 provide Northfield Center Township with 11,746.87 deputy/sergeant hours, for the period of
36 1/1/15 through 12/31/17, in exchange for payment by Northfield Center Township, in the amount
37 of \$769,287.09 for the first year, \$787,258.53 for the second year and \$804,720.52 for the third
38 year, for a total amount of \$2,361,266.14 during the three-year term of the contract.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the citizens of the County of Summit and for the further purpose of immediately
44 providing necessary policing for Northfield Center Township, in Council District 1, effective
45 1/1/15.
