7 **A Resolution authorizing the County Executive to advertise for bids for two utility service**  
8 **boxes/bodies for two 2015 Ford F-550 trucks, for an estimated total cost not to exceed**  
9 **\$70,000.00, for the Executive's Department of Environmental Services, and declaring an**  
10 **emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for two utility service  
16 boxes/bodies for two 2015 Ford F-550 trucks; and

18 WHEREAS, a copy of the technical specifications is attached as Exhibit A; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
22 advertise for bids for two utility service boxes/bodies for two 2015 Ford F-550 trucks;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that;

27 SECTION 1

29 The County Executive is authorized to advertise for bids for two utility service  
30 boxes/bodies for two 2015 Ford F-550 trucks, for an estimated total cost not to exceed  
31 \$70,000.00.

33 SECTION 2

35 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
36 of the citizens of the County of Summit, and for the further reason that it authorizes the  
37 Executive to immediately advertise for bids for the utility service boxes/bodies in 2015.

39 SECTION 3

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.

45 SECTION 4

47 It is found and determined that all formal actions of this Council concerning and relating  
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
49 deliberations of this Council and any of its committees that resulted in such formal action, were  
50 in meetings open to the public, in compliance with all legal requirements, including Section  
51 121.22 of the Ohio Revised Code.
