12 WHEREAS, the Board of Control, at its meeting held April 22, 2015, awarded Summer
13 Youth Employment Program agreements with certain providers per attached Exhibit A, for
14 monitoring services and work readiness skills classes, for the period 5/1/15 through 9/30/15,
15 subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the agreements are necessary and in the best interest of the County of Summit;

26 with certain providers per attached Exhibit A, for monitoring services and work readiness skills
27 classes, for the period 5/1/15 through 9/30/15, in a total amount not to exceed \$247,881.00, is
28 hereby confirmed and the County Executive is hereby authorized to execute such agreements.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide for summer youth employment monitor services effective 5/1/15.

39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.
