7 **A Resolution authorizing the County Executive to execute an Ohio Public Works**
8 **Commission grant application and any other documents necessary to apply for and accept**
9 **Local Transportation Improvement Program grant funds, for resurfacing of Brandywine**
10 **Road, in Northfield Center Township and Sagamore Hills Township, in the amount of**
11 **\$360,000.00, with no local cash match requirement, for the Engineer, and declaring an**
12 **emergency.**

13
14 WHEREAS, the County Engineer concludes that there is a public need for the resurfacing
15 of Brandywine Road from State 82 to south of Marwyck Drive in Northfield Center Township
16 and Sagamore Hills Township, in Council District 1, and

17
18 WHEREAS, the County of Summit is eligible to acquire Ohio Public Works Commission
19 Local Transportation Improvement Program ("LTIP") grant funds, in the amount of
20 \$360,000.00, with no local cash match requirement, for resurfacing of Brandywine Road; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to authorize the County
24 Executive to execute an Ohio Public Works Commission grant application and the County
25 Engineer to execute any other documents necessary to accept and administer LTIP grant funds
26 for the aforementioned purpose;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

31 SECTION 1

32
33 The County Executive is authorized to execute an Ohio Public Works grant application
34 and the County Engineer to execute any other documents necessary to accept and administer a
35 grant for Ohio Public Works Commission Local Transportation Improvement Program ("LTIP")
36 funds, for the purpose of resurfacing of Brandywine Road from State Route 82 to south of
37 Marwyck Drive ("Project"), in Northfield Center Township and Sagamore Hills Township, in
38 Council District 1, with no local cash match requirement, in the amount of \$360,000.00.

40 SECTION 2

42 The terms of said application shall request 100% of the cost of said project from the Ohio
43 Public Works Commission.

45 SECTION 3

46
47 The County Executive is authorized to execute said grant application necessary to apply
48 for the aforementioned grant funds only for the Ohio Public Works Program Year 30, with
49 further authorization required for any future grant applications for the purpose of resurfacing of
50 Brandywine Road.

7 County Engineer, for submission to the Ohio Public Works Commission with said grant
8 application.

12 This Resolution is hereby declared an emergency in the interest of the health, safety and
13 welfare of the citizens of the County of Summit, and for the further reason that it will allow the
14 County to obtain grant funds for an immediately needed resurfacing project in Council District 1.

16 SECTION 6

18 Provided this Resolution receives the affirmative vote of eight members, it shall take
19 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
20 effect and be in force at the earliest time provided by law.

24 It is found and determined that all formal actions of this Council concerning and relating
25 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
26 deliberations of this Council and of any of its committees that resulted in such formal action,
27 were in meetings open to the public, in compliance with all legal requirements, including Section
28 121.22 of the Ohio Revised Code.
