9 **commercial plan review and construction inspection services for the Miller's Farm**
10 **Subdivision, in an amount not to exceed \$32,457.96 (129.8% increase), and appropriating**
11 **funds, for the period ending 12/31/2015, for the Engineer, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 27, 2015, awarded Change
14 Order No. 1 to a professional service contract with Environmental Design Group, LLC, for
15 additional commercial plan review and construction inspection services for the Miller's Farm
16 Subdivision, in Council District 5, subject to confirmation by County Council; and

18 WHEREAS, Change Order No. 1 for additional commercial plan review and construction
19 inspection services for the Miller's Farm Subdivision requires appropriation in the amount of
20 \$37,457.96 from the Motor Vehicle Gas Tax Fund; and

22 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
23 that the change order is necessary and in the best interest of the County of Summit;
