7 **A Resolution authorizing the County Executive to submit a resolution at the National**  
8 **Association of Counties 2015 Annual Conference to include support for the EB-5 Regional**  
9 **Center Program in NACo's American County Platform, for the Executive and Council,**  
10 **and declaring an emergency.**

12 WHEREAS, The National Association of Counties ("NACo") is an important policy  
13 group that provides a voice for all member counties in the United States at the federal level; and

15 WHEREAS, NACo is able to provide support for policies that would assist counties  
16 across the United States through their American County Platform; and

18 WHEREAS, the EB-5 Regional Center Program ("Program") is a federal program that  
19 provides counties with the necessary tools to assist investment, job creation and infrastructure;

22 WHEREAS, the Program has brought investment, development and jobs to Summit  
23 County, specifically as a component of the redevelopment of the former Goodyear Tire and  
24 Rubber Company headquarters; and

26 WHEREAS, the County Executive desires to submit a resolution that would add support  
27 of the Program to NACo's American County Platform at NACo's 2015 Annual Conference; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
30 that it is necessary and in the best interest of the County to authorize the Executive to submit a  
31 resolution at NACo's 2015 Annual Conference to include support for the Program in NACo's  
32 American County Platform.

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that:

39 The County Executive is authorized to submit a resolution at the National Association of  
40 Counties 2015 Annual Conference to include support for the EB-5 Regional Center Program in
