7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **MCM Home Service, for home repairs and lead abatement at 459 Inman Street in the City**
9 **of Akron, in Council District 4, in an amount not to exceed \$36,550.00, for the Executive's**
10 **Department of Community and Economic Development, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held June 17, 2015, awarded a
13 construction contract with MCM Home Service, for home repairs and lead abatement of a home
14 at 459 Inman Street in the City of Akron, in Council District 4, subject to confirmation by
15 County Council; and

17 WHEREAS, pursuant to Resolution No. 2014-120, this Council authorized the
18 competitive bidding of this project; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned contract is necessary and in the best interest of the County of Summit.

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of a construction contract with MCM Home Service,
29 for the home repair and lead abatement of a home at 459 Inman Street in the City of Akron, in
30 Council District 4, in an amount not to exceed \$36,550.00, is hereby confirmed and the County
31 Executive is hereby authorized to execute such contract.

35 This Resolution is hereby declared an emergency in the interest of the health, safety, and
36 welfare of the citizens of the County of Summit and for the further reason to immediately
37 authorize the home repairs and lead abatement for the health and safety of the residents of the
38 home.

42 Provided this Resolution received the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.
