7 **A Resolution confirming an award by the Board of Control of an intergovernmental**
8 **agreement with the City of Akron for providing unleaded and diesel fuel for County**
9 **vehicles, for a five-year term, from 1/01/15 through 12/31/19, in the amount of \$.08 per**
10 **gallon over the City of Akron's wholesale cost, for an approximate cost of \$400,979.72 per**
11 **year based upon 2014 figures, for the Executive's Department of Finance and Budget, and**
12 **declaring an emergency.**

14 WHEREAS, County Council previously approved Resolution No. 2010-066, which
15 confirmed an award by the Board of Control of an intergovernmental agreement with the City of
16 Akron for providing unleaded and diesel fuel for County vehicles, for a five-year term, from
17 1/01/10 through 12/31/14, in the amount of \$.08 per gallon over the City of Akron's wholesale
18 cost, for an approximate cost of \$242,000.00 per year based upon 2008 figures; and

20 WHEREAS, the County and Akron have agreed to a new intergovernmental agreement,
21 pursuant to which Akron will provide unleaded and diesel fuel for County vehicles, for the
22 period 1/01/15 through 12/31/19, in the amount of \$.08 per gallon over the City of Akron's
23 wholesale cost, for an approximate cost of \$400,979.72 per year based upon 2014 figures; and

25 WHEREAS, the intergovernmental agreement with the City of Akron is exempt from
26 competitive bidding as a contract with another governmental unit pursuant to Section
27 177.07(a)(2) of the Codified Ordinances of the County of Summit; and

29 WHEREAS, the Board of Control, at its meeting held July 1, 2015, awarded the
30 aforementioned intergovernmental agreement with Akron for fuel, subject to confirmation by
31 County Council; and

33 WHEREAS, County Council finds and determines, after reviewing all pertinent
34 information, that the aforementioned intergovernmental agreement with the City of Akron is
35 necessary and in the best interest of the County of Summit;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

42 The award by the Board of Control of an intergovernmental agreement with the City of
43 Akron for providing unleaded and diesel fuel for County vehicles, for a five-year term, from
44 1/01/15 through 12/31/19, in the amount of \$.08 per gallon over the City of Akron's wholesale
45 cost, for an approximate cost of \$400,979.72 per year based upon 2014 figures, is hereby
46 confirmed, and the County Executive is authorized to execute such contract.

50 This Resolution is hereby declared an emergency in the interest of the health, safety and
51 welfare of the citizens of the County of Summit, and for the further purpose of immediately
52 authorizing the Executive to execute a contract with Akron to provide fuel for County vehicles.
