7 **Resolution authorizing the County Executive to advertise for bids for a purchase contract**  
8 **to provide food service at the Summit County Jail and the Glenwood Jail, for a term of one**  
9 **year, with four options to renew for an additional one-year term, for an estimated first year**  
10 **amount not to exceed \$750,000.00, for the Sheriff, declaring an emergency.**

12 WHEREAS, the County's current purchase contract with Aramark Correctional Services,  
13 LLC to provide food service at the Summit County Jail and the Glenwood Jail ends on 11/30/15;  
14 and

16 WHEREAS, the County Sheriff requests that the County Executive be authorized to  
17 advertise for bids for a purchase contract to provide food service at the Summit County Jail and  
18 the Glenwood Jail, for a term of one year, with four options to renew for an additional one-year  
19 term, for an estimated first year amount not to exceed \$750,000.00; and

21 WHEREAS, a copy of the bid specifications are attached to this Resolution as Exhibit A;

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
26 advertise for bids for a purchase contract to provide food service at the Summit County Jail and  
27 the Glenwood Jail, for a term of one year, with four options to renew for an additional one-year  
28 term, for an estimated first year amount not to exceed \$750,000.00;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

35 The County Executive to advertise for bids for a purchase contract to provide food  
36 service at the Summit County Jail and the Glenwood Jail, for a term of one year, with four  
37 options to renew for an additional one-year term, for an estimated first year amount not to exceed  
38 \$750,000.00.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit and for the further reason that it is immediately  
44 necessary in order to have a purchase contract to provide food service at the Summit County Jail  
45 and the Glenwood Jail in place by 12/1/15.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take  
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
51 effect and be in force at the earliest time provided by law.
