7 **A Resolution confirming an award by the Board of Control of a renewal (second of two) of**  
8 **intergovernmental agreement with the County of Summit Court of Common Pleas –**  
9 **Juvenile Division for Jobs Reentry Program services, for a one-year term, from 10/1/15**  
10 **through 9/30/16, in an amount not to exceed \$115,000.00, for the Executive’s Department of**  
11 **Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 26, 2015, awarded a  
14 renewal (second of two) of intergovernmental agreement with the County of Summit Court of  
15 Common Pleas – Juvenile Division for Jobs Reentry Program services, for a one-year term, from  
16 10/1/15 through 9/30/16, in an amount not to exceed \$115,000.00, subject to confirmation by  
17 County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that the aforementioned second renewal of the intergovernmental agreement with the County of  
21 Summit Court of Common Pleas – Juvenile Division is necessary and in the best interest of the  
22 County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:

27 SECTION 1

29 The award by the Board of Control of a renewal (second of two) of intergovernmental  
30 agreement with the County of Summit Court of Common Pleas – Juvenile Division for Jobs  
31 Reentry Program services, for a one-year term, from 10/1/15 through 9/30/16, in an amount not  
32 to exceed \$115,000.00, is hereby confirmed and the County Executive is hereby authorized to  
33 execute such renewal of the intergovernmental agreement.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and  
38 welfare of the citizens of the County of Summit, and for the further reason to immediately  
39 provide for Jobs Reentry Program services effective 10/1/15.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
