7 **A Resolution confirming an award by the Board of Control of a renewal (first of four) of a**  
8 **purchase contract with Metro Regional Transit Authority, as a Best Practical Source, to**  
9 **provide transportation services for work mandated recipients, for a one-year term, from**  
10 **10/1/15 through 9/30/16, in an amount not to exceed \$187,500.00, for the Executive's**  
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held on September 23, 2015, awarded a  
14 renewal (first of four) of a purchase contract with Metro Regional Transit Authority, as a Best  
15 Practical Source, to provide transportation services for work mandated recipients for the  
16 Executive's Department of Job and Family Services, for a one-year term, from 10/1/15 through  
17 9/30/16, in an amount not to exceed \$187,500.00, subject to confirmation by County Council;

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the aforementioned renewal of a purchase contract with Metro Regional Transit Authority is  
22 necessary and in the best interest of the County of Summit;

24 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:

27 SECTION 1

29 The award by the Board of Control of a renewal (first of four) of a purchase contract with  
30 Metro Regional Transit Authority, as a Best Practical Source, to provide transportation services  
31 for work mandated recipients for the Executive's Department of Job and Family Services  
32 ("DJFS"), for a one-year term, from 10/1/15 through 9/30/16, in an amount not to exceed  
33 \$187,500.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
34 purchase contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and  
39 welfare of the citizens of the County of Summit, and for the further purpose of immediately  
40 authorizing the Executive to execute a necessary purchase contract to provide transportation  
41 services for work mandated recipients for DJFS.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.
