7 **A Resolution approving the new classification, classification specification and salary**  
8 **schedule for the non-bargaining, unclassified position of Veterinarian, #40006 and revising**  
9 **the County's 2016 Staffing Report to include said position, for the Executive's Department**  
10 **of Administrative Services' Division of Animal Control and the Executive's Department of**  
11 **Human Resources, and declaring an emergency.**

13 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10)  
14 of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the  
15 Codified Ordinances to establish classifications, classification specifications and pay/salary  
16 schedules for all County employees; and

18 WHEREAS, the County Executive wishes to create the new classification of  
19 Veterinarian, #40006 in order to recruit a full-time veterinarian to fill an operational need within  
20 the Executive's Department of Administrative Services' Division of Animal Control; and

21  
22 WHEREAS, the Executive requests that this Council approve the new classification,  
23 classification specification and salary schedule for the non-bargaining, unclassified position of  
24 Veterinarian, #40006 in order to achieve said goal; and

25  
26 WHEREAS, it is necessary to add said classification to the County's 2016 Staffing  
27 Report; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
30 it is necessary and in the best interest of the County of Summit to approve the new classification,  
31 classification specification and salary schedule for the non-bargaining, unclassified position of  
32 Veterinarian, #40006 and to add said classification to the County's 2016 Staffing Report for the  
33 aforementioned reasons;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

48 aforementioned classification is assigned the salary schedule of Category CE, Grade 9, as set  
49 forth in Exhibit B, which is attached to this Resolution.

14 welfare of the citizens and employees of the County of Summit, and for the further reason that it  
15 is necessary in order to immediately approve the new classification, classification specification  
16 and salary schedule for the non-bargaining, unclassified position of Veterinarian, #40006 in  
17 order to successfully recruit a full-time veterinarian to fill an operational need within the  
18 Executive's Department of Administrative Services' Division of Animal Control.

22 Provided this Resolution receives the affirmative vote of eight (8) members, it shall take  
23 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect  
24 and be in force at the earliest time provided by law.
