7 **A Resolution authorizing the County Executive to execute a one-year contract with the**  
8 **County of Summit Alcohol, Drug Addiction and Mental Health Services Board for the**  
9 **County Sheriff's Office to provide non-Medicaid behavioral health services through its**  
10 **Drug Abuse Resistance Education unit, for the period 1/1/16 through 12/31/16, for the total**  
11 **amount of \$86,900.00, for the Sheriff, and declaring an emergency.**

13 WHEREAS, the County of Summit Alcohol, Drug Addiction and Mental Health Services  
14 ("ADM") Board wishes to execute a one-year contract with the County for the County Sheriff's  
15 Office to provide non-Medicaid behavioral health services through its Drug Abuse Resistance  
16 Education ("DARE") unit, for the period 1/1/16 through 12/31/16, for which ADM has agreed to  
17 pay the County the total amount of \$86,900.00; and

19 WHEREAS, the County wishes to provide said services through the DARE unit; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that the aforementioned contract with ADM is necessary and in the best interest of the County of  
23 Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that;

28 SECTION 1

29  
30 The County Executive is hereby authorized to execute a one-year contract with the  
31 County of Summit Alcohol, Drug Addiction and Mental Health Services ("ADM") Board, which  
32 is attached hereto as Exhibit A, for the County Sheriff's Office to provide non-Medicaid  
33 behavioral health services through its Drug Abuse Resistance Education ("DARE") unit, for the  
34 period 1/1/16 through 12/31/16, for the total amount of \$86,900.00 during the term of the  
35 contract. The County Executive is hereby authorized to execute the contract in substantially the  
36 form attached hereto as Exhibit A. The contract is approved with changes therein not  
37 inconsistent with this Resolution and not substantially adverse to the County which shall be  
38 approved by the County Executive; provided that the approval of those changes by the County  
39 Executive and the character of such changes as not being substantially adverse to the County  
40 shall be evidenced conclusively by the execution of the contract.

44 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
45 welfare of the citizens of the County of Summit and for the further purpose of immediately  
46 authorizing the Sheriff's Office to provide non-Medicaid behavioral health services through the  
47 Sheriff Office's DARE unit to the ADM Board in 2016.
