7 **A Resolution authorizing the County Executive to execute a professional service contract**
8 **between the Legal Defenders Office of Summit County, Ohio, Inc. and the Summit County**
9 **Public Defender Commission, subject to the approval of the Board of Control, for legal**
10 **defender services for indigents for the Commission, for the period 1/1/16 to 12/31/16, in an**
11 **amount not to exceed \$545,800.00, for the Executive and the Summit County Public**
12 **Defender Commission, and declaring an emergency.**

14 WHEREAS, the County has formed the Summit County Public Defender Commission
15 pursuant to Chapter 120 the Ohio Revised Code (“ORC”); and

16
17 WHEREAS, the Commission is responsible for providing legal defense services to
18 certain indigent persons charged with the commission of crimes under the ORC, the Codified
19 Ordinances of the County of Summit and various municipal ordinances within the boundaries of
20 the County; and

22 WHEREAS, the Commission is authorized by Section 120.14 of the Ohio Revised Code
23 to contract with a nonprofit organization to provide legal services to indigent persons; and

25 WHEREAS, the Commission wishes to contract with the Legal Defenders Office of
26 Summit County, Ohio, Inc., a nonprofit corporation, to provide legal representation to indigent
27 persons on behalf of the Commission from 1/1/16 to 12/31/16, for an amount not to exceed
28 \$545,800.00; and

30 WHEREAS, the County Executive is required to execute the aforementioned contract,
31 the cost of which will be paid out of funds appropriated by Council in Account No. 10003-2711-
32 45501 pursuant to Resolution No. 2015-496; and

34 WHEREAS, said professional service contract with the Legal Defenders Office of
35 Summit County, Ohio, Inc., is subject to the approval of the Board of Control; and

37 WHEREAS, this County Council finds and determines, after reviewing all pertinent
38 information, that it is necessary and in the interest of the County of Summit to authorized the
39 Executive to execute the aforementioned contract with the Legal Defenders Office of Summit
40 County, Ohio, Inc., subject to the approval of the Board of Control;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that:

47 The County Executive is hereby authorized to execute a professional service contract
48 with the Legal Defenders Office of Summit County, Ohio, Inc., subject to the approval of the
49 Board of Control, for legal defender services for indigents, for the Summit County Public
50 Defender Commission, for the period 1/1/16 to 12/31/16, for an amount not to exceed
51 \$545,800.00.

14 effect and be in force at the earliest time provided by law.

19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
