7 **A Resolution adjusting existing appropriations by \$100,000.00 within the Court of**  
8 **Common Pleas- Juvenile Division's U.S. Department of Justice, Office of Juvenile Justice**  
9 **and Delinquency Prevention's Family Drug Court Implementation Project grant, for the**  
10 **period of 10/1/13 to 9/30/16, for the Court of Common Pleas- Juvenile Division and**  
11 **declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2013-438, which authorized  
14 the County Executive to execute any documents necessary to accept an award from the U.S.  
15 Department of Justice, Office of Juvenile Justice and Delinquency Prevention of a Family Drug  
16 Court Implementation Project grant, for the Fiscal Years 2014-2016, in the amount of  
17 \$538,363.00, with no local cash match requirement, and appropriating funds, for the period of  
18 10/1/13 to 9/30/16; and

20 WHEREAS, an adjustment to appropriations, in the amount of \$100,000.00, is required  
21 because the cost of contract services was underestimated; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that the aforementioned appropriations adjustment is necessary and in the best interest of the  
25 County of Summit;

SECTION 4




