7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a grant award of federal funds from the U.S. Department of Justice, Office on**
9 **Violence Against Women, for the County Prosecutor’s Domestic Violence Unit, for the**
10 **period of 10/1/15 through 9/30/18, in the amount of \$749,978.00, with no local cash match**
11 **requirement, and appropriating funds, for the Prosecutor, and declaring an emergency.**

13 WHEREAS, the U.S. Department of Justice (“DOJ”), Office on Violence Against
14 Women has awarded a grant of federal funds to the County Prosecutor’s Domestic Violence Unit
15 for the period 10/1/15 through 9/30/18, in the amount of \$749,978.00, with local cash match
16 requirement; and

18 WHEREAS, the grant program funding supports three Assistant Prosecutor positions, one
19 Investigator position, and training and travel for Prosecutor’s Domestic Violence Unit; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
23 execute any documents necessary to accept the award of the aforementioned grant from DOJ and
24 to appropriate these grant funds;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

31 The County Executive is hereby authorized to execute any documents necessary to accept
32 the award of a grant award from the Department of Justice (“DOJ”), Office on Violence Against
33 Women, for the County Prosecutor’s Domestic Violence Unit, for the period of 10/1/15 through
34 9/30/18, in the amount of \$749,978.00, with no local cash match requirement.

15 Positions, one Investigator position, and provide training and travel for the Prosecutor's
16 Domestic Violence Unit.

21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.
