7 **A Resolution confirming an award by the Board of Control of an IV-D intergovernmental**
8 **agreement with the County Clerk of Court for reimbursement of filing fees in child support**

12 WHEREAS, the Board of Control, at its meeting on February 3, 2016, awarded an IV-D
13 intergovernmental agreement with the County Clerk of Court for reimbursement of filing fees in
14 child support cases for the Prosecutor's Child Support Enforcement Agency, for a one-year term,
15 from 1/1/2016 to 12/31/16, in an amount not to exceed \$150,000.00; and

17 WHEREAS, this Council finds and determines after reviewing all pertinent information,
18 that the aforementioned IV-D intergovernmental agreement with the County Clerk of Court is
19 necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of an IV-D intergovernmental agreement with the
27 County Clerk of Court for reimbursement of filing fees in child support cases for the
28 Prosecutor's Child Support Enforcement Agency, for a one-year term, from 1/1/16 to 12/31/16,
29 in an amount not to exceed \$150,000.00 is hereby confirmed and the County Executive is hereby
30 authorized to execute such intergovernmental agreement.

34 This Resolution is hereby declared an emergency in the interest of the health, safety, and
35 welfare of the citizens of the County of Summit and for the further purpose of immediately
36 providing necessary reimbursement of filing fees for the Prosecutor's Child Support
37 Enforcement Agency effective 1/1/16.
