7 **A Resolution appropriating funds from the County of Summit Alcohol, Drug Addiction,**
8 **and Mental Health Services Board for the Psycho-Diagnostic Clinic for the period of 1/1/16**
9 **through 12/31/16, in the amount of \$452,261.99, with no local cash match requirement, for**
10 **the Court of Common Pleas- General Division, and declaring an emergency.**

12 WHEREAS, the County of Summit Alcohol, Drug Addiction, and Mental Health
13 Services Board (“ADM”) has certified that pass-through grant funds are available, primarily
14 from the Ohio Department of Mental Health, with additional funding from ADM, for the period
15 of 1/1/16 through 12/31/16, in the amount of \$416,921.00, with no local cash match
16 requirement,; and

18 WHEREAS, additional court revenues in the amount of \$12,000.00, with no local cash
19 match requirement, are available along with the aforementioned 2016 grant award; and

21 WHEREAS, the County Court of Common Pleas- General Division has various carryover
22 funds totaling \$23,340.99; and

24 WHEREAS, the Psycho-Diagnostic Clinic is needed to provided court-ordered
25 evaluations in criminal cases, and the aforementioned monies will be used to reimburse the
26 Clinic for expenditures; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information
29 that it is necessary and in the best interest of the County of Summit to appropriate the
30 aforementioned funds, in the amount of \$452,261.99, with no local cash match requirement;


