7 **A Resolution confirming an award by the Board of Control of Change Order No. 2 to a**
8 **professional service contract with Environmental Design Group, LLC. for additional**
9 **commercial plan reviews and construction inspection task orders performed in 2015, in an**
10 **amount not to exceed \$20,773.02 (a 303.1% cumulative increase), for the Engineer, and**
11 **declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution 2015-522, which confirmed
14 the award of Change Order No. 1 to a professional service contract with Environmental Design
15 Group, LLC., for additional commercial plan reviews and construction inspection task orders
16 performed in 2015, in an additional amount not to exceed \$55,000.00 (a 220% cumulative
17 increase); and

19 WHEREAS, the Board of Control, at its meeting held on February 24, 2016, awarded
20 Change Order No. 2 to a professional service contract with Environmental Design Group, LLC.,
21 for additional commercial plan reviews and construction inspection task orders performed in
22 2015, in an amount not to exceed \$20,773.02 (a 303.1% cumulative increase), subject to
23 confirmation by County Council; and

25 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
26 that Change Order No. 2 to a professional service contract with Environmental Design Group,
27 LLC. is necessary and in the best interest of the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

34 The award by the Board of Control of Change Order No. 2 to a professional services
35 contract with Environmental Design Group, LLC. for additional commercial plan reviews and
36 construction inspection task orders performed in 2015, in an amount not to exceed \$20,773.02 (a
37 303.1% cumulative increase) is hereby confirmed and the County Executive is hereby authorized
38 to execute such change order.

43 welfare of the citizens of the County of Summit and for the further reason to immediately
44 approve Change Order No. 2 to a professional service contract with Environmental Design

46 performed in 2015.
