7 **A Resolution authorizing the County Executive to execute a Local Public Agency**
8 **agreement with the State of Ohio Department of Transportation for replacement of the**
9 **Home Avenue Bridge over the Little Cuyahoga, at a net cost to the County not to exceed**
10 **\$324,520.00, for the Engineer, and declaring an emergency.**

11
12 WHEREAS, the County Engineer finds a public need for the replacement of the Home
13 Avenue Bridge over the Little Cuyahoga, Bridge No. AKR-011-0002, located in the City of
14 Akron, in Council District 2 ("Project"); and

15
16 WHEREAS, the Project's estimated total cost for construction, construction engineering
17 and inspection ("Project's Construction Cost") is \$1,624,000.00; and

18
19 WHEREAS, the Federal Highway Administration has committed \$1,299,480.00 towards
20 the Project's construction costs; and

21
22 WHEREAS, the County of Summit plans to provide the remaining of the Project's
23 Construction Cost, in an amount not to exceed \$324,520.00, to be paid from Motor Vehicle Gas
24 Tax Funds; and

25
26 WHEREAS, State of Ohio Department of Transportation ("ODOT") and the County
27 Engineer desire to enter into a Local Public Agency agreement, to confirm the Project's
28 construction cost and to designate the County of Summit as the lead agency for administration of
29 competitive bidding, construction and construction engineering of the Project; and

30
31 WHEREAS, Sections 5501.03(c) and 5543.01 of the Ohio Revised Code, as well as
32 Article II, Section 2.03(5) of the County of Summit Charter, authorizes the County Executive to
33 execute such agreements, subject to the approval of County Council; and

34
35 WHEREAS, the local public agency agreement will state that up to a maximum of
36 \$1,299,480.00 will be provided to the Project from the County Engineer's Association of Ohio
37 Local Bridge Program funds; and

39 WHEREAS, no funds will be expended for the Project's construction until and unless
40 authorized by separate Resolutions; and

42 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
43 that authorizing the County Executive to execute a Local Public Agency agreement with ODOT
44 for the Project is necessary and in the best interest of the County of Summit;

46 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
47 of Ohio, that:

4 SECTION 1

5
6 The County Executive is hereby authorized to execute a Local Public Agency agreement
7 with the State of Ohio Department of Transportation (“ODOT”), for the improvement of the
8 Home Avenue Bridge over the Little Cuyahoga, Bridge No. AKR-011-0002, located in City of
9 Akron, in Council District 2 (“Project”).

10
11 SECTION 2

12
13 The terms of the Local Public Agency agreement shall include the following:

- 14
15 a. That the parties estimate the Project’s construction cost to be \$1,624,000.00; and
16
17 b. That the net estimated cost to the County of Summit shall be an amount not to exceed
18 \$324,520.00; and
19
20 c. That the County of Summit shall provide all other financial resources necessary to
21 fully complete the Project; and
22
23 d. That, upon receipt of federal authorization from ODOT, the County of Summit may
24 commence competitive bidding activities for Project construction, with award of
25 contract subject to applicable Codified Ordinances of the County of Summit, said
26 ordinances requiring authorization of such an award by this Council; and

28 SECTION 3

29
30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason that it immediately
32 completes a prerequisite for the Project to proceed in a timely manner in 2016.

33
34 SECTION 4

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

40 SECTION 5

42 It is found and determined that all formal actions of this Council concerning and relating
43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,
45 were in meetings open to the public, in compliance with all legal requirements, including Section
46 121.22 of the Ohio Revised Code.
