7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Montrose Ford, Inc., for five new vehicles, under CUE pricing, in a total amount not to**

13 purchase contract with Montrose Ford, Inc. for five 2016 Ford S FWD Escape SUVs, under CUE
14 pricing, in a total amount not to exceed \$99,709.70, subject to confirmation by County Council;

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned purchase contract with Montrose Ford, Inc. is necessary and in the best
19 interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a purchase contract with Montrose Ford, Inc. for
27 five 2016 Ford S FWD Escape SUVs, under CUE pricing, in a total amount not to exceed
28 \$99,709.70, is hereby confirmed and the County Executive is hereby authorized to execute such
29 purchase contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 replace unreliable vehicles in 2016.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
