7 **A Resolution authorizing the Executive to execute a deferral agreement with the**  
8 **Development Finance Authority of Summit County to defer payments under a Loan**  
9 **Agreement and Promissory Note dated March 31, 2011, for the Executive's Department of**  
10 **Finance and Budget, and declaring an emergency.**

11  
12 WHEREAS, in 2011, the County sold certain real property located at 47 N. Main St,  
13 Akron, OH 44308 (the "Property") to the Development Finance Authority of Summit County  
14 ("DFA") to serve as the headquarters for the Austen BioInnovation Institute of Akron ("ABIA");  
15 and

16  
17 WHEREAS, to finance the purchase of the Property, the DFA executed a Loan  
18 Agreement and Promissory Note dated March 31, 2011 ("Loan and Note") agreeing to repay the  
19 purchase price of \$2,490,000.00 in twenty equal installments of \$86,739.00 due annually by the  
20 15<sup>th</sup> of March of each year and two payments of \$377,070.00 due on March 15, 2032 and March  
21 15, 2033; and

23 WHEREAS, for the first five years of the term of the Loan and Note, the County rented  
24 floors four, five and six of the Property and the revenue derived from the Lease provided the  
25 funds necessary for the DFA to repay the Loan and Note; and

26  
27 WHEREAS, the County has vacated the space it leased in the Property and, due to the  
28 reorganization and transition of its mission, ABIA is not yet ready to assume and pay rent for the  
29 space previously occupied by the County; and

30  
31 WHEREAS, the County Executive has proposed deferring the payments due under the  
32 Loan and Note for the period of March 15, 2017 to March 15, 2021, with the deferred payments  
33 being added to the final payment due under the terms of the Loan and Note; and

35 WHEREAS, the County Executive has proposed said deferment in order to provide the  
36 DFA and ABIA sufficient time for ABIA to expand into the fourth, fifth and sixth floors and/or  
37 sublease the space for compatible medical and biomedical uses; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
40 that it is necessary and in the best interest of the County of Summit to execute a deferral  
41 agreement with the DFA whereby payments due on the Loan and Note for March 15, 2017 to  
42 March 15, 2021 are deferred and added to the final payment due under the terms of the Loan and  
43 Note.

45 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
46 of Ohio, that:

48 SECTION 1

50 The County Executive is hereby authorized to execute a deferral agreement with the DFA  
51 whereby payments due on the Loan and Note for March 15, 2017 to March 15, 2021 are deferred  
52 and added to the final payment due under the terms of the Loan and Note.

5  
6 This Resolution is hereby declared an emergency in the interest of the health, safety and  
7 welfare of the citizens of the County of Summit and for the further purpose of immediately  
8 authorizing the Executive to timely execute the deferral agreement in order to provide relief and  
9 avoid any potential breach/default of the Loan and Note.

11 SECTION 3

12  
13 Provided this Resolution receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.

17 SECTION 4

19 It is found and determined that all formal actions of this Council concerning and relating  
20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
21 deliberations of this Council and of any of its committees that resulted in such formal action,  
22 were in meetings open to the public, in compliance with all legal requirements, including Section  
23 121.22 of the Ohio Revised Code.
