12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the Board of Elections
16 Renovation Project, located at 500 Grant Street, Akron, Ohio 44311, in Council District 4; and

18 WHEREAS this Council finds and determines, after reviewing all pertinent information
19 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
20 advertise for bids for the aforementioned project;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

27 The County Executive is authorized to advertise for bids for the Board of Elections
28 Renovation Project, located at 500 Grant Street, Akron, Ohio 44311, in Council District 4, for an
29 estimated total cost not to exceed \$449,700.00. A copy of the bid specifications shall be
30 submitted to the Clerk of Council prior to advertising for bids.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the
36 Executive to immediately advertise for bids in order to complete the renovation project prior to
37 the beginning of early voting for the general election of 2016.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.
