7 **A Resolution pursuant to Chapter 355 of the Ohio Revised Code, establishing the Summit**
8 **County Healthier Buckeye Council, for the Executive's Department of Jobs and Family**
9 **Services, and declaring an emergency.**

10
11 WHEREAS, Ohio House Bill 64, the most recent biennial budget bill, appropriated \$11.5
12 million over the biennium for the Healthier Buckeye Pilot Program; and

13
14 WHEREAS, the Healthier Buckeye Council Pilot Program is designed to provide grant
15 funding to local initiatives that promote financial self-sufficiency and reduced reliance on public
16 assistance, through a community environment that maximizes opportunities for individuals and
17 families to achieve optimal health in all aspects; and

18
19 WHEREAS, grant proposals to the Healthier Buckeye Pilot Program may be submitted
20 only by a local Healthier Buckeye Council established under Chapter 355 of the Ohio Revised
21 Code; and

22
23 WHEREAS, in order to establish a Healthier Buckeye Council for Summit County, this
24 Council must adopt a resolution pursuant to Section 355.02 of the Ohio Revised Code; and

26 WHEREAS, to maintain consistency in social service planning and delivery, this Council
27 and the Executive have determined that the organization of the Summit County Buckeye Council
28 should mirror membership of the Summit County Social Services Advisory Board's ("SSAB")
29 Executive Committee and Health and Human Services Committee; and

31 WHEREAS, this Council and the Executive have further determined that, as a member of
32 the SSAB Executive Committee, and therefore a member of the Summit County Healthier
33 Buckeye Council, the Health Commissioner of the Summit County Combined Health District
34 ("Health District"), or his/her designee(s) from among the Health District staff shall serve as the
35 staffing agent for the Summit County Healthier Buckeye Council; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
38 that it is necessary and in the best interest of the County of Summit to establish the Summit
39 County Healthier Buckeye Council.

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that:

47 The Summit County Healthier Buckeye Council is hereby established pursuant to Section
48 355.02 of the Ohio Revised Code.

4 SECTION 2

6 Membership on the Healthier Buckeye Council shall consist of and be limited to the
7 members of the Summit County Social Services Advisory Board's ("SSAB") Executive
8 Committee and Health and Human Services Committee. As the membership of the
9 aforementioned SSAB committees may change from time to time, the membership of the
10 Summit County Healthier Buckeye Council shall concurrently change.

12 SECTION 3

13
14 The Health Commissioner of the Summit County Combined General Health District
15 ("Health District"), who is also a member of the SSAB Executive Committee, or his/her
16 designee(s) from among the Health District staff shall serve as the staffing agent for the Summit
17 County Healthier Buckeye Council.

19 SECTION 4

21 This Resolution is hereby declared an emergency in the interest of the health, safety and
22 welfare of the citizens of the County of Summit, and for the further purpose of immediately
23 establishing the Summit County Healthier Buckeye Council to apply for funds under the
24 Healthier Buckeye Pilot Program.

26 SECTION 5

27
28 Provided this Resolution receives the affirmative vote of eight members, it shall take
29 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
30 effect and be in force at the earliest time provided by law.

32 SECTION 6

33
34 It is found and determined that all formal actions of this Council concerning and relating
35 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
36 deliberations of this Council and of any of its committees that resulted in such formal action,
37 were in meetings open to the public, in compliance with all legal requirements, including Section
38 121.22 of the Ohio Revised Code.
