8 **accept the award of a Federal Fiscal Year 2016 Victims of Crime Act grant from the State**
9 **of Ohio Attorney General's Office, for the period of 10/1/15 through 9/30/16, in the amount**
10 **of \$732.00, with a local cash match requirement of \$183.00, and appropriating said grant**
11 **funds, for the Court of Common Pleas-Juvenile Division, and declaring an emergency.**

13 WHEREAS, the County of Summit, Court of Common Pleas- Juvenile Division has
14 received an award from the State of Ohio Attorney General's Office of a Federal Fiscal Year
15 ("FFY") 2016 Victims of Crime Act ("VOCA") grant for the period 10/1/15 through 9/30/16, in
16 the amount of \$732.00, with a local cash match requirement of \$183.00, for a VOCA award total
17 of \$915.00; and

19 WHEREAS, the local match requirement will be provided by the Court of Common
20 Pleas-Juvenile Division's General Fund; and

22 WHEREAS, the grant funds allow a juvenile employee to attend the 2016 Two Days in
23 May Victims Assistance conference in Columbus, Ohio; and
