7 **A Resolution authorizing the County Executive to execute a purchase contract with Callos**
8 **Resource, LLC and/or its subsidiary American Payroll Service, LLC, subject to the**
9 **approval of Board of Control, to provide payroll services for the 2016 Summer Youth**
10 **Employment Program, for the period 5/1/16 through 9/30/16, in an amount not to exceed**
11 **\$2,138,120.88, for the Executive's Department of Job and Family Services, and declaring**
12 **an emergency.**

14 WHEREAS, this Council previously adopted Resolution No. 2016-100, which authorized
15 the County Executive to advertise for bids for a vendor to provide payroll services for the 2016
16 Summer Youth Employment Program, for the period of 5/1/16 through 9/30/16, for an estimated
17 cost not to exceed \$2,372,500.00; and

19 WHEREAS, this Council wishes to enter into a purchase contract with Callos Resource,
20 LLC and/or its subsidiary American Payroll Service, LLC, both affiliates of Nesco Design
21 Corporation, a Delaware Corporation doing business in Ohio as Nesco Resource, subject to the
22 approval of the Board of Control, to provide payroll services for the 2016 Summer Youth
23 Employment Program, for pass through wages, FICA, Worker's Compensation, and
24 administrative fees, for the period 5/1/16 through 9/30/16, in an amount not to exceed
25 \$2,138,120.88, to be paid from Temporary Assistance for Needy Families ("TANF") funds; and

27 WHEREAS, this Council finds and determines after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to authorize the County
29 Executive to execute the aforementioned purchase contract, subject to Board of Control
30 approval;

32 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State
33 of Ohio, that:

37 The County Executive is hereby authorized to execute a purchase contract with Callos,
38 LLC and/or its subsidiary American Payroll Services, LLC, both affiliates of Nesco Design
39 Corporation, a Delaware Corporation, doing business in Ohio as Nesco Resource, subject to the
40 approval of the Board of Control, to provide payroll services for the 2016 Summer Youth
41 Employment Program, for pass through wages, FICA, Worker's Compensation and
42 administrative fees, for the period 5/1/16 through 9/30/16, in an amount not to exceed
43 \$2,138,120.88, to be paid from Temporary Assistance for Needy Families ("TANF") funds.

47 This Resolution is hereby declared to be an emergency in the interest of the health, safety
48 and welfare of the citizens of the County of Summit and for the further reason that it is necessary
49 to immediately provide required payroll services for the 2016 Summer Youth Employment
