7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Cleveland Freightliner, Inc., under Ohio Department of Transportation Cooperative**  
9 **Purchasing, for the purchase of one Western Star 4900SF conventional cab truck tractor**  
10 **with tandem rear axle and utility construction dump body, in an amount not to exceed**  
11 **\$180,220.00, for the Executive's Department of Sanitary Sewer Services, and declaring an**  
12 **emergency.**

14 WHEREAS, the Board of Control, at its meeting held May 4, 2016, awarded a purchase  
15 contract with Cleveland Freightliner, Inc., under Ohio Department of Transportation Cooperative  
16 Purchasing, for the purchase of one Western Star 4900SF conventional cab truck tractor with  
17 tandem rear axle and utility construction dump body, in an amount not to exceed \$180,220.00,  
18 subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines after reviewing all pertinent information  
21 that the aforementioned purchase contract with Cleveland Freightliner, Inc. is necessary and in  
22 the best interest of the County of Summit;

24 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State  
25 of Ohio, that:

27 SECTION 1

29 The award by the Board of Control of a purchase contract with Cleveland Freightliner,  
30 Inc., under Ohio Department of Transportation Cooperative Purchasing, for the purchase of one  
31 Western Star 4900SF conventional cab truck tractor with rear axle and utility construction dump  
32 body, in an amount not to exceed \$180,220.00, is hereby confirmed and the County Executive is  
33 hereby authorized to execute such purchase contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and  
38 welfare of the citizens of the County of Summit, and for the further reason to immediately  
39 provide for the purchase of a Western Star 4900SF conventional cab truck tractor with rear axle  
40 and utility construction dump body to replace aging/non-functioning equipment for the  
41 Executive's Department of Sanitary Sewer Services.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.
