7 **A Resolution confirming an award by the Board of Control of a construction contract to**  
8 **American Roadway Logistics, Inc., for the 2016 Summit County Pavement Marking**  
9 **Program, in an amount not to exceed \$144,334.65, for the Engineer, and declaring an**  
10 **emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 27, 2016, awarded a  
13 construction contract with American Roadway Logistics, Inc., for the 2016 Summit County  
14 Pavement Marking Program, in an amount not to exceed \$144,334.65, subject to confirmation by  
15 County Council; and

17 WHEREAS, this Council finds and determines after reviewing all pertinent information,  
18 that the aforementioned construction contract with American Roadway Logistics, Inc. is  
19 necessary and in the best interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a construction contract with American Roadway  
27 Logistics, Inc., for the 2016 Summit County Pavement Marking Program, in an amount not to  
28 exceed \$144,334.65, is hereby confirmed and the County Executive is hereby authorized to  
29 execute such construction contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 provide for the 2016 Summit County Pavement Marking Program.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,  
48 were in meetings open to the public, in compliance with all legal requirements, including Section  
49 121.22 of the Ohio Revised Code.
