7 **A Resolution confirming an award by the Board of Control of Change Order No. 2 to a**
8 **professional services contract with Environmental Design Group, LLC, for additional**
9 **commercial plan reviews and construction inspection task orders for calendar year 2015, in**
10 **an amount not to exceed \$20,773.02 (a 303.1% cumulative increase), for a total amount of**
11 **\$100,773.02, for the Engineer, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2015-522, which confirmed
14 Change Order No. 1 to a professional service contract with Environmental Design Group, LLC,
15 for additional commercial plan reviews and construction inspection task orders for 2015, in an
16 amount not to exceed \$55,000.00 (a 220% increase), for a total amount of \$80,000.00; and

18 WHEREAS, the Board of Control, at its meeting held May 4, 2016, awarded Change
19 Order No. 2 to a professional service contract with Environmental Design Group, LLC for
20 additional commercial plan reviews and construction inspection task orders for calendar year
21 2015, in an amount not to exceed \$20,773.02 (a 303.1% cumulative increase), for a total amount
22 of \$100,773.02;

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information
25 that the aforementioned Change Order No. 2 to the professional service contract with
26 Environmental Design Group, LLC is necessary and in the best interest of the County of
27 Summit;

29 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

34 The award by the Board of Control of Change Order No. 2 to a professional service
35 contract with Environmental Design Group LLC for additional commercial plan reviews and
36 construction inspection task orders for calendar year 2015, in an amount not to exceed
37 \$20,773.02 (a 303.1% cumulative increase), for a total amount of \$100,773.02, is hereby
38 confirmed and the County Executive is hereby authorized to execute such change order.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the citizens of the County of Summit, and for the further reason to immediately
44 provide commercial plan reviews and construction inspection task orders for the County.

49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
