7 **A Resolution confirming an award by the Board of Control of a renewal (second and final)**  
8 **of a purchase contract with Waste Management for trash removal services at various**  
9 **facilities, for the period 6/1/16 through 5/31/18, in an amount not to exceed \$94,165.04, for**  
10 **the Executive's Department of Finance and Budget, and declaring an emergency**

12 WHEREAS, the Board of Control, at its meeting held May 4, 2016, awarded a renewal  
13 (second and final) of a purchase contract with Waste Management for trash removal services at  
14 various facilities, for the period 6/1/16 through 5/31/18, in an amount not to exceed \$94,165.04,  
15 subject to confirmation by County Council and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
18 that the aforementioned purchase contract with Waste Management is necessary and in the best  
19 interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a renewal (second and final) of a purchase contract  
27 with Waste Management for trash removal services at various facilities, in a total amount not to  
28 exceed \$94,165.04 is hereby confirmed and the County Executive is hereby authorized to  
29 execute such renewal. .

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 provide trash removal services effective 6/1/16.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,  
48 were in meetings open to the public, in compliance with all legal requirements, including Section  
49 121.22 of the Ohio Revised Code.


