7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an Ohio Courts Technology Initiative grant from the Supreme Court of Ohio, for**
9 **the period 5/4/16 through 9/1/16, in the amount of \$5,968.58, with no local cash match**
10 **requirement, and appropriating said grant funds, for the Ninth District Court of Appeals,**
11 **and declaring an emergency.**

13 WHEREAS, the Supreme Court of Ohio has awarded the Ninth District Court of Appeals
14 an Ohio Courts Technology Initiative grant, for the period 5/4/16 through 9/1/16, in an amount
15 of \$5,968.58, with no local cash match requirement; and

17 WHEREAS, the aforementioned Ohio Courts Technology Initiative grant will be used to
18 upgrade network equipment to permit secure remote access and create a guest network for
19 attorneys to utilize when they are present at the courthouse for oral arguments; and

21 WHEREAS, it is necessary to appropriate said grant funds; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to authorize the County
25 Executive to execute any documents necessary to accept the award of the aforementioned Ohio
26 Courts Technology Initiative grant and to appropriate said grant funds;

28 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State
