7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Kenworth of Richfield, for the purchase of two 2017 tandem axle dump trucks, in a total**  
9 **amount not to exceed \$218,708.00, for the Engineer, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held May 11, 2016, awarded a purchase  
12 contract to Kenworth of Richfield, for the purchase of two 2017 tandem axle dump trucks with  
13 cab and chassis components, in an amount not to exceed \$218,708.00 subject to confirmation by  
14 County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
17 that the aforementioned purchase contract with Kenworth of Richfield is necessary and in the  
18 best interest of the County of Summit;

20 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State  
21 of Ohio, that:

23 SECTION 1

25 The award by the Board of Control of a purchase contract with Kenworth of Richfield,  
26 for the purchase of two tandem axle dump trucks with cab and chassis components, in an amount  
27 not to exceed \$218,708.00, is hereby confirmed and the County Executive is hereby authorized  
28 to execute such purchase contract.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of health, safety and  
33 welfare of the citizens of the County of Summit, and for the further reason to immediately  
34 provide for the purchase of necessary equipment for the Engineer.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take  
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating  
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
46 deliberations of this Council and of any of its committees that resulted in such formal action,  
47 were in meetings open to the public, in compliance with all legal requirements, including Section  
48 121.22 of the Ohio Revised Code.
