7 **A Resolution confirming an award by the Board of Control of an intergovernmental**  
8 **agreement with Summit County Public Health, for community health worker services, for**  
9 **the period 5/1/16 through 9/30/16, in an amount not to exceed \$100,000.00, for the**  
10 **Executive's Department of Job and Family Services, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held May 18, 2016, awarded an  
13 intergovernmental agreement with Summit County Public Health, for community health worker  
14 services to aid in the initiative to reduce infant mortality, for the period 5/1/16 through 9/30/16,  
15 in an amount not to exceed \$100,000.00, subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
18 that the aforementioned intergovernmental agreement is necessary and in the best interest of the  
19 County of Summit;

21 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State  
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of an intergovernmental agreement with Summit  
27 County Public Health, for community health worker services to aid in the initiative to reduce  
28 infant mortality, for the period 5/1/16 through 9/30/16, in an amount not to exceed \$100,000.00,  
29 is hereby confirmed and the County Executive is hereby authorized to execute such  
30 intergovernmental agreement.

34 This Resolution is hereby declared an emergency in the interest of health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide for community health worker services to aid in the initiative to reduce infant mortality  
37 effective 5/1/16.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating  
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
49 deliberations of this Council and of any of its committees that resulted in such formal action,
