7 **A Resolution authorizing the Executive to execute an intergovernmental agreement with**  
8 **the City of Cuyahoga Falls for a joint Steels Corner Road and Bridge Resurfacing Project,**  
9 **for an estimated cost to the County not to exceed \$35,000.00, for the Engineer, and**  
10 **declaring an emergency.**

11  
12 WHEREAS, the City of Cuyahoga Falls is partnering with the City of Stow to resurface  
13 Steels Corners Road (the "Project") with the City of Cuyahoga Falls as the lead agent; and

14  
15 WHEREAS, the Project will include the 1,052 foot long County owned bridge over Mud  
16 Brook (STW-100-0940), located in the City of Stow; and

17  
18 WHEREAS, the County Engineer has determined the bridge is in need of patching and  
19 repairs to the bridge surface; and

20  
21 WHEREAS, the contractor that will be hired by the City of Cuyahoga Falls will be  
22 performing a similar type of work; and

23  
24 WHEREAS, the County and the City of Cuyahoga Falls have agreed to partner for the  
25 contract to include the resurfacing of the County-owned Steels Corners Bridge over Mud Brook;  
26 and

28 WHEREAS, the County and ODOT wish to enter into an intergovernmental agreement  
29 for the Project, for an estimated cost to the County not to exceed \$35,000.00; and

31 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
32 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
33 an intergovernmental agreement with the City of Cuyahoga Falls for the Steels Corner Road and  
34 Bridge Resurfacing Project;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
37 of Ohio, that;

39 SECTION 1

41 The County Executive is hereby authorized to execute an intergovernmental agreement  
42 with the City of Cuyahoga Falls for the joint Steels Corners Road and Bridge Resurfacing  
43 Project at an estimated cost to the County not to exceed \$35,000.00 for the bridge portion of the  
44 Project. The County Executive is hereby authorized to execute said intergovernmental  
45 agreement in substantially the form attached to this Resolution as Exhibit A.

49 This Resolution is hereby declared an emergency in the interest of the health, safety and  
50 welfare of the citizens of the County of Summit, and for the further purpose to immediately

6 allow the Executive to execute said intergovernmental agreement and allow the Engineer and the  
7 City of Cuyahoga Falls to move forward with a necessary resurfacing project.

11 Provided this Resolution receives the affirmative vote of eight members, it shall take  
12 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
13 effect and be in force at the earliest time provided by law.

17 It is found and determined that all formal actions of this Council concerning and relating  
18 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
19 deliberations of this Council and of any of its committees that resulted in such formal action,  
20 were in meetings open to the public, in compliance with all legal requirements, including Section  
21 121.22 of the Ohio Revised Code.
