7 **A Resolution rescinding Resolution No. 2015-447, for the Engineer, and declaring an**
8 **emergency.**

10 WHEREAS, County Council previously adopted Resolution No. 2015-447, which
11 confirmed an award by the Board of Control of a purchase contract with C&K Industrial to clean
12 the County sewer system and inspect the system via video, in an amount not to exceed
13 \$50,087.00; and

15 WHEREAS, it is necessary to use the procedures for professional service contracts set
16 forth in Chapter 177 of the Codified Ordinances of the County of Summit in order to select a
17 vendor; and

19 WHEREAS, because of the need to use the procedures for professional service contracts
20 to select a vendor, it is further necessary to rescind Resolution No. 2015-447; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to rescind Resolution No.
24 2015-447 for the aforementioned reason;

26 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
27 State of Ohio, that:

31 Resolution No. 2015-447 is hereby rescinded in its entirety.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit and for the further purpose of immediately
37 rescinding Resolution No. 2015-447 to allow a rebid of a project to clean the County sewer
38 system.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

48 It is found and determined that all formal actions of this Council concerning and relating
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,

52 121.22 of the Ohio Revised Codes.
