7 **A Resolution pursuant to Section 177.13 of the Codified Ordinances of the County of**  
8 **Summit, authorizing purchases by the Court of Common Pleas- General Division from the**  
9 **Community Health Center, as a Best Practical Source, for drug screen testing services, in a**  
10 **total aggregate amount not to exceed \$75,000.00, in calendar year 2016, for the Court of**  
11 **Common Pleas - General Division, Adult Probation Department, and declaring an**  
12 **emergency.**

13  
14 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit  
15 requires that purchases of an officeholder exceeding \$50,000.00 in aggregate in any calendar  
16 year, where no additional competitive quotes or bids have been taken, shall be made only upon  
17 authorization of County Council; and

18  
19 WHEREAS, the County Executive's Department of Finance and Budget and the Board of  
20 Control have previously approved purchases by the Court of Common Pleas - General Division,  
21 Adult Probation Department from the Community Health Center, as a Best Practical Source, for  
22 drug screen testing services, in the aggregate amount of \$35,000.00 for calendar year 2016; and

24 WHEREAS, the Court of Common Pleas- General Division, Adult Probation Department  
25 anticipates additional purchases from Community Health Center, as a Best Practical Source, for  
26 drug screen testing services, in an additional amount not to exceed \$40,000.00, for a total  
27 aggregate amount not to exceed \$75,000.00 in calendar year 2016; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
30 that it is necessary and in the best interest of the County of Summit to authorize purchases by the  
31 Court of Common Pleas - General Division, Adult Probation Department from the Community  
32 Health Center, as a Best Practical Source, for drug screen testing services, in a total aggregate  
33 amount not to exceed \$75,000.00 in calendar year 2016;

35 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
36 of Ohio, that:

40 This Council hereby authorizes purchases by the Court of Common Pleas - General  
41 Division, Adult Probation Department from the Community Health Center, as a Best Practical  
42 Source, for drug screen testing services, in a total aggregate amount not to exceed \$75,000.00, in

6 This Resolution is hereby declared an emergency in the interest of the health, safety and  
7 welfare of the citizens of the County of Summit, and for the further reason to immediately  
8 provide necessary drug screen testing services for the Court of Common Pleas - General  
9 Division, Adult Probation Department in calendar year 2016.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.

20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
