7 **A Resolution confirming an award by the Board of Control of a renewal (second and final)**
8 **of a professional service contract with United Labor Agency for adult/dislocated worker**
9 **employment services, for the period 7/1/16 through 6/30/17, in an amount not to exceed**
10 **\$963,318.00, for the Executive's Department of Job and Family Services, and declaring an**
11 **emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2014-281, which
14 authorized the County Executive to execute a professional service contract with United Labor
15 Agency, subject to the approval of the Board of Control, for employment services for adults,
16 dislocated workers, and displaced homemakers, for the period 7/1/14 through 6/30/15, in an
17 amount not to exceed \$963,318.00, with two options to renew for an additional one-year term;

20 WHEREAS, County Council previously adopted Resolution No. 2015-126, which
21 confirmed the award by the Board of Control of a professional service contract renewal (first of
22 two) with United Labor Agency, for employment services for adults, dislocated workers, and
23 displaced homemakers, for the period 7/1/15 through 6/30/16, in the amount not to exceed
24 \$963,318.00; and

26 WHEREAS, the Board of Control, at its meeting held June 1, 2016, awarded a renewal
27 (second and final) of a professional service contract with United Labor Agency for
28 adult/dislocated employment services, for the period 7/1/16 through 6/30/17, in an amount not to
29 exceed \$963,318.00, subject to confirmation by County Council; and

31 WHEREAS, this Council finds and determines after reviewing all pertinent information,
32 that the aforementioned professional service contract with United Labor Agency is necessary and
33 in the best interest of the County of Summit;

35 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
