8 **An Ordinance approving and adopting the current replacement pages for the Codified**  
9 **Ordinances of the County of Summit, for County Council, and declaring an emergency.**

12 WHEREAS, the County has entered into a contract with Walter H. Drane Company to  
13 prepare and publish an updating of the ordinances of the County of Summit; and

15 WHEREAS, certain provisions within the Codified Ordinances should be amended to  
16 conform with current State law as required by the Ohio Constitution; and

18 WHEREAS, the updating of the related laws, ordinances, and resolutions, together with  
19 the proper numbering or renumbering thereof has been prepared, completed, and is now before  
20 this Council; now

22 THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State of  
23 Ohio, that:

25 SECTION 1

27 The Ordinances and Resolutions of the County of Summit, Ohio, enacted between April  
28 1, 2015 and April 1, 2016, all of which have been previously enacted and adopted by the County  
29 Council, are hereby approved as numbered or renumbered and printed in the 2016 Replacement  
30 Pages as prepared by the Walter H. Drane Company, of Cleveland, Ohio.

32 SECTION 2

34 The sections of the Traffic and General Offenses Codes as listed in Appendix A and  
35 attached as Exhibit A - of this ordinance are hereby added, amended or repealed as respectively  
36 indicated in order to comply with current State law.

40 The Clerk of Council is hereby directed to distribute the 2016 Replacement Pages to  
41 those individuals possessing Codification Books and to instruct those individuals responsible for  
42 updating the books to do so in an efficient and timely manner.

5 SECTION 4

7 This Ordinance is hereby declared an emergency to provide an additional means of  
8 exercise of powers and administration over local matters for the County of Summit in the interest  
9 of the health, safety, and welfare of the citizens of the County of Summit.

13 Provided this Ordinance receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in full force at the earliest time provided by law.

19 It is found and determined that all formal actions of this Council concerning and relating  
20 to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all  
21 deliberations of this Council and of any of its committees that resulted in such formal action,  
22 were in meetings open to the public, in compliance with all legal requirements, including Section  
23 121.22 of the Ohio Revised Code.
