7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**  
8 **Summit, authorizing purchases by the Sheriff in calendar year 2016 from Shaw's**  
9 **Automotive, as a Best Practical Source, for maintenance and repairs for the Sheriff's**  
10 **Office fleet of vehicles, for a total aggregate amount not to exceed \$90,000.00, for the**  
11 **Sheriff, and declaring an emergency.**

12  
13 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit  
14 requires that purchases by an officeholder exceeding \$50,000.00 in aggregate in any calendar  
15 year, where no additional competitive quotes or bids have been taken, shall be made only upon  
16 authorization of County Council; and

17  
18 WHEREAS, the Executive's Department of Finance and Budget has previously approved  
19 purchases by the County Sheriff from Shaw's Automotive, as a Best Practical Source, for  
20 vehicle maintenance and repairs for \$50,000.00; and

21  
22 WHEREAS, the Sheriff expects to spend another \$40,000.00, for a total not to exceed  
23 \$90,000.00; and

25 WHEREAS this Council finds and determines, after reviewing all pertinent information,  
26 that it is necessary and in the best interest of the County to authorize purchases by the Sheriff in  
27 calendar year 2016 from Shaw's Automotive, as a Best Practical Source, for the maintenance and  
28 repairs of sheriff's office vehicles, for a total aggregate amount not to exceed \$90,000.00;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

33 SECTION 1

35 This Council hereby authorizes purchases by the Sheriff in calendar year 2016 from  
36 Shaw's Automotive, as a Best Practical Source, for the maintenance and repairs of sheriff's  
37 office vehicles, for a total aggregate amount not to exceed \$90,000.00.

39 SECTION 2

41 This Resolution is hereby declared an emergency in the interest of the health, safety and  
42 welfare of the citizens of the County of Summit, and for the further reason to immediately  
43 authorize the Sheriff to make necessary purchases for maintenance and repairs of vehicles for the  
44 Sheriff's office in calendar year 2016.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.
