7 **A Resolution confirming an award by the Board of Control of a renewal (second of four) of**
8 **a professional service contract with Metro Regional Transit Authority, as a Best Practical**
9 **Source, to provide transportation to employment and training related activities for work**
10 **mandated recipients, for a one-year term, for the period 10/1/16 through 9/30/17, in an**
11 **amount not to exceed \$187,500.00 for the Executive's Department of Job and Family**
12 **Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held August 17, 2016, awarded a
15 renewal (second of four) of a professional service contract with Metro Regional Transit
16 Authority, as a Best Practical Source, to provide transportation to employment and training
17 related activities for work mandated recipients, for a one-year term, for the period 10/1/16 to
18 9/30/17, in an amount not to exceed \$187,500.00, subject to confirmation by County Council;

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information
22 that the aforementioned renewal of said professional service contract with Metro Regional
23 Transit Authority is necessary and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

30 The award by the Board of Control of a renewal of a professional service contract with
31 Metro Regional Transit Authority, as a Best Practical Source, to provide transportation services
32 to employment and training related activities and for work mandated recipients, for a one-year
33 term, from 10/1/16 to 9/30/17, in an amount not to exceed \$187,500.00, is hereby confirmed and
34 the County Executive is hereby authorized to execute such renewal of said professional service
35 contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit, and for the further reason to provide
41 transportation services effective 10/1/16.

46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
