7 **A Resolution authorizing the County Executive to execute agreements for the acquisition of**
8 **drainage easements and temporary easements for the Greenwich Road Improvement**
9 **Project located in the City of Norton, at a cost not to exceed \$600.00, for the Engineer, and**
10 **declaring an emergency.**

11
12 WHEREAS, the County Engineer has determined that a bridge on Greenwich Road, in
13 the City of Norton, in Council District 7, is deficient and in need of replacement; and

14
15 WHEREAS, the Greenwich Road Improvement Project involves the improvement of
16 0.02 miles of CR 97 (Greenwich Road) by replacement of a deficient bridge over an unnamed
17 tributary to Hudson Run, including work on the approach roadway, grading and work on the
18 guardrail; and

19
20 WHEREAS, rights-of-way ("ROW") are needed for the Project; and

21
22 WHEREAS, ROW acquisition is considered a "local cost" which must be borne in whole
23 by the local public agency performing a project, in this case being the County of Summit; and

24
25 WHEREAS, acquisition of the drainage easements and temporary easements will allow
26 the Project to proceed to bid; and

27
28 WHEREAS, the drainage easements and temporary easements will be purchased from the
29 owners for a total amount not to exceed \$600.00; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that it is necessary and in the best interest of the County of Summit to authorize the County
33 Executive to execute agreements for the acquisition of drainage easements and temporary
34 easements for the Greenwich Road Improvement Project for a total amount not to exceed
35 \$600.00;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that;

42 The County Executive is hereby authorized to execute agreements for the acquisition of
43 drainage easements and temporary easements for the Greenwich Road Improvement Project,
44 located in the City of Norton, in Council District 7, pursuant to which the owners of the
