7 **A Resolution accepting the recommendations of the Tax Incentive Review Council**
8 **regarding numerous enterprise zone agreements in Summit County, in Council Districts 1,**
9 **2, 3 and 7, for the Executive's Department of Community and Economic Development, and**
10 **declaring an emergency.**

12 WHEREAS, the County of Summit, with the consent of several townships and
13 municipalities within the County, has designated certain areas within those townships and
14 municipalities as enterprise zones, pursuant to Sections 5709.61 through 5709.69 of the Ohio
15 Revised Code ("O.R.C."); and

16
17 WHEREAS, the purpose of said enterprise zone is to provide these townships and
18 municipalities with an effective tool for managing and guiding economic development by
19 enhancing the tax base by encouraging and sustaining long term investment in these
20 communities by enhancing the quality of life, and by preserving existing business and attracting
21 new business; and

23 WHEREAS, the County of Summit has previously entered into several enterprise zone
24 agreements with various business for the abatement of portions of the business' real property
25 and/or tangible personal property taxes as incentives for the business to invest in the
26 communities; and

27
28 WHEREAS, O.R.C. § 5709.85 requires a county that enters into an enterprise zone
29 agreement to appoint a Tax Incentive Review Council ("TIRC") to review each enterprise zone
30 agreement, to review each business' compliance with each agreement and make certain
31 recommendations to either continue, modify or terminate said agreements; and

33 WHEREAS, pursuant to O.R.C. § 5709.85, the Council of the County of Summit is
34 required to either accept, reject or modify all or any portion of the recommendations of the
35 TIRC; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
38 that it is necessary and in the best interest of the County of Summit to accept the
39 recommendations of the TIRC regarding numerous enterprise zone agreements within Summit
40 County;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
