7 **A Resolution authorizing the County's Department of Job and Family Services to transfer**
8 **an amount not to exceed \$300,000.00 in Title XX/TANF and/or Title XX Base funds,**
9 **collectively, to Summit County Children Services, for the Executive's Department of Job**
10 **and Family Services, and declaring an emergency.**

12 WHEREAS, the County Executive's Department of Job and Family Services ("DJFS") is
13 the recipient of certain Title XX/TANF and Title XX Base funds, which it receives as part of its
14 annual allocation; and

15
16 WHEREAS, DJFS has received an allocation from the State of Ohio of Title XX/TANF
17 and Title XX Base funds for DJFS for the period 10/1/15 through 9/30/16; and

18
19 WHEREAS, Summit County Children Services ("SCCS") provides protective services
20 for children and emancipating out of foster care services that are eligible expenses for the use of
21 Title XX/TANF and/or Title XX Base funds; and

22
23 WHEREAS, in exchange for providing such services, DJFS will transfer an amount not
24 to exceed \$300,000.00 in Title XX/TANF and/or Title XX Base funds, collectively, to SCCS to
25 be used for Non-Allocated Children's costs; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to authorize the transfer of an
29 amount not to exceed \$300,000.00 in Title XX/TANF and/or Title XX Base funds, collectively,
30 to SCCS, and to authorize the Executive to execute any documents necessary to effectuate said
31 transfer;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The County Executive, through the Department of Job and Family Services, is hereby
39 authorized to transfer an amount not to exceed \$300,000.00 in Title XX/TANF and/or Title XX
40 Base funds, collectively, to Summit County Children Services ("SCCS") to be used for Non-
41 Allocated Children's Services costs, and the County Executive is further authorized to execute
42 any documents necessary to effectuate said transfer.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens of the County of Summit and for the further reason to immediately
48 authorize the transfer of said Title XX/TANF and/or Title XX Base funds, collectively, to SCCS.


