7 **A Resolution authorizing the County Executive to execute any documents necessary to**
 8 **accept an award of a Federal Fiscal Year 2017 Safe Communities grant from the Ohio**
 9 **Department of Public Safety, through its Ohio Traffic Safety Office, for the period 10/1/16**
 10 **to 9/30/17, for a Safe Communities Program in Summit County, in the amount of**
 11 **\$65,000.00, with no local cash match requirement, and appropriating said grant funds, for**
 12 **the Sheriff, and declaring an emergency.**

14 WHEREAS, the Ohio Department of Public Safety (“ODPS”) through its Ohio Traffic
 15 Safety Office (“OTSO”) has awarded the County Sheriff’s Office a Federal Fiscal Year (“FFY”)
 16 2017 Safe Communities grant for a Safety Communities Program in Summit County, for the
 17 period 10/1/16 to 9/30/17, in the amount of \$65,000.00, with no local cash match requirement,
 18 and;

20 WHEREAS, this Council has determined by reviewing all pertinent information that
 21 authorizing the County Executive to execute any documents necessary to accept the
 22 aforementioned grant from ODPS through OTSO and to appropriate said grant funds;
