7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Job and Family Services of a State Fiscal**
9 **Year 2017 Comprehensive Case Management Employment Program grant of Temporary**
10 **Assistance for Needy Families funds, for the period 7/1/16 through 6/30/17, in the amount**
11 **of \$3,660,875.00, with no local cash match requirement, and appropriating the amount of**
12 **\$900,000.00 for the period of 7/1/16 through 12/31/16, for the Executive's Department of**
13 **Job and Family Services, and declaring an emergency.**

15 WHEREAS, the County Executive's Department of Job and Family Services ("SCJFS")
16 has received an award of federal funds from the Ohio Department of Job and Family Services
17 ("ODJFS") for a State Fiscal Year 2017 Comprehensive Case Management Employment
18 Program grant of Temporary Assistance for Needy Families ("TANF") funds, in the amount of
19 \$3,660,875.00, with no local cash match requirement; and

21 WHEREAS, this TANF funding will support employment training and other supportive
22 services to TANF-eligible participants ages 16-24 based upon a comprehensive assessment of
23 individual participants' employment and training needs; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the County
27 Executive to execute any documents necessary to accept the award of the aforementioned State
28 Fiscal Year 2017 Comprehensive Case Management Employment Program grant of TANF
29 funds, in the amount of \$3,660,875.00, with no local cash match requirement, and appropriating
30 the amount of \$900,000.00 for the period of 7/1/16 through 12/31/16;
