7 **A Resolution authorizing the County Executive to execute a one-year policing contract with**
8 **the Summit County Combined General Health District d.b.a. Summit County Public**
9 **Health to provide two full-time Sheriff's detectives and two one-shift vehicles for Summit**
10 **County Adult Protective Services, for the period 10/1/16 through 9/30/17, for a total**
11 **amount of \$222,766.66, for the Sheriff, and declaring an emergency.**

13 WHEREAS, the Summit County Combined General Health District d.b.a. Summit
14 County Public Health wishes to enter into a one-year policing contract with the County of
15 Summit to provide two full-time Sheriff's detectives and two one-shift vehicles for Summit
16 County Adult Protective Services, for the period 10/1/16 through 9/30/17; and

18 WHEREAS, the Summit County Combined General Health District d.b.a. Summit
19 County Public Health has agreed to pay the County the amount of \$18,563.89 per month, for a
20 total amount of \$222,766.66, for the period 10/1/16 through 9/30/17; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned one-year policing contract with the Summit County Combined General
24 Health District d.b.a. Summit County Public Health is necessary and in the best interest of the
25 County of Summit;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that;

32 The County Executive is hereby authorized to execute a one-year policing contract with
33 the Summit County Combined General Health District d.b.a. Summit County Public Health to
34 provide two full-time Sheriff's detectives and two one-shift vehicles for Summit County Adult
35 Protective Services, for the period 10/1/16 through 9/30/17, for a total amount of \$222,766.66.

39 This Resolution is hereby declared an emergency in the interest of the health, safety, and
40 welfare of the citizens of the County of Summit and for the further purpose of immediately
41 providing necessary policing to the Summit County Combined General Health District d.b.a.
42 Summit County Public Health effective 10/1/16.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.



10 121.22 of the Ohio Revised Code.


