7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Montrose Ford, Inc., for three new vehicles, at CUE pricing, in a total amount not to**
9 **exceed \$57,692.49, for the Prosecutor, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held November 9, 2016, awarded a
12 purchase contract with Montrose Ford, Inc. for two 2017 Ford Fusions, and one 2017 FWD Ford
13 Escape, at CUE pricing, in a total amount not to exceed \$57,692.49, subject to confirmation by
14 County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information
17 that the aforementioned purchase contract with Montrose Ford, Inc. is necessary and in the best
18 interest of the County of Summit;

20 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a purchase contract with Montrose Ford, Inc. for
26 two 2017 Ford Fusions and one 2017 FWD Ford Escape, at CUE pricing, in a total amount not to
27 exceed \$57,692.49, is hereby confirmed and the County Executive is hereby authorized to
28 execute such purchase contract.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 replace unreliable vehicles in the Prosecutor's office fleet.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,
