10 **for the period 7/1/17 through 6/30/18, and appropriating these grant funds, for the**
11 **Executive's Department of Law, Insurance and Risk Management–Division of Public**
12 **Safety/Emergency Management Agency, and declaring an emergency.**

14 WHEREAS, the Ohio Emergency Management Agency has granted a Fiscal Year 2018
15 Statewide Search and Rescue Grant to the Summit County Emergency Management Agency in
16 the amount of \$7,250.00, with no local cash match requirement, for the period 7/1/17 through
17 6/30/18; and

19 WHEREAS, the purpose of the grant is to help sustain the Region 5 collapse search and
20 rescue capabilities through the purchase of equipment, expendable materials and supplies; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to authorize the County
24 Executive to execute any documents necessary to accept the award of the aforementioned grant
25 and to appropriate these grant funds;
